LA VISTA CITY COUNCIL MEETING December 6, 2011

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on December 6, 2011. REPORTS FROM CITY ADMINISTRATOR AND DEPARTMENT HEADS

Recreation Director Stopak reported that the city received a plaque from Slump Busters to thank the city for all the help with the tournament. Councilmember Crawford asked about the trail and what is the city's responsibility for maintenance and parking. Public Works Director Soucie stated that the city will maintain the trail and people using the trail can use city parking areas when open — trail head areas will be shown on map where people can park.

Library Director Barcal reported that the library had over 40 people signed up for ginger bread house making, and were also preparing for a day of music and treats.

Police Chief Lausten reported that the animal ordinance will be on the agenda at the next meeting.

B. RESOLUTION – BID AWARD – FLORESCENT LIGHTING REPLACEMENT – PUBLIC WORKS FACILITY EECBG AWARD NO. 9/10-E062

Councilmember Carlisle introduced and moved for the adoption of Resolution No. 11-133; A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AWARING A CONTRACT TO OMAHA ELECTRIC SERVICE, OMAHA NEBRASKA FOR REPLACEMENT OF FLOURESCENT LIGHTING TUBES AND BALLASTS IN THE PUBLIC WORKS FACILITY IN AN AMOUNT NOT TO EXCEED \$12,779.82.

WHEREAS, the City Council of the City of La Vista has determined that the replacement of existing fluorescent tubes and ballasts is necessary; and

WHEREAS, the funding will come from a grant from the U.S. Department of Energy and the American Recovery and Reinvestment Act of 2009, Grant No. EECBG Award No. 9/10-E062, and from saving in the FY 11/12 Public Works budget; and

WHEREAS, on November 15, 2011, the City Council approved an amendment to the EECBG Aid Agreement to utilize the balance of the awarded grant funds for replacement of the fluorescent lighting tubes and ballasts in the Public Works facility, and

WHEREAS Omaha Electric Service of Omaha, Nebraska, has submitted the low, qualified bid, and

WHEREAS Subsection (C) (9) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secures Council approval prior to authorizing any purchase over \$5,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska designate Omaha Electric Service, Omaha, Nebraska as the low qualified bidder for replacement of fluorescent lighting tubes and ballasts in the Public Works facility in an amount not to exceed \$12,779.82.

WHEREAS, the City Council has determined that it is necessary to control erosion in the creek in preparation for installing a hiking/biking trail along the creek as part of the Portal Greenway project, and

WHEREAS, the FY 11/12 Capital Improvement Program (CIP) provides funding for this project, and

WHEREAS, the City Engineer in conjunction with Thompson, Dreessen, and Dorner, Inc. has prepared plans and specifications for the Applewood Creek Improvements to obtain bids.

NOW, THEREFORE BE IT RESOLVED, that the City Administrator is hereby authorized to advertise for bids for the construction of drainageway stabilization measures in Applewood Creek between the BNSF railroad and Giles Road with specifications prepared by the City Engineer in conjunction with Thompson, Dreessen, and Dorner, Inc. and said bids are to be opened and publicly read aloud at 10 a.m. at the office of the City Clerk, 8116 Park View Boulevard, La Vista, Nebraska on January 5, 2012.
