-101 Cases Voluntary Compliance



Executive Summary










Interagency Coordination, Meetings & Training

Code Enforcement Officer Ruppert attended a meeting with members from the Building Inspector, City Planners Office, Sgt. Brian Stolley and Captain Barcal. Several sign violations were brought to the attention of Officer Ruppert. One was a realtor sign in the right of way for the Brentwood Plaza businesses; the other was for Dual Stop at Harrison and 110th Streets. The Dual Stop issue has been resolved and the Brentwood Plaza sign will be followed up on once the snow melts. It is possible the sign is either covered in snow or has been removed. The address of 7115 S. 78th Street was discussed due to a sidewalk obstruction. It has been resolved.


Count of Category




VIOLATIONS BY DISTRICTS FOR February 2019



District 171 96th to 126th/Giles to Harrison







