SYNOPSIS

A resolution has been prepared authorizing the purchase of one (1) John Deere 1570 Front Mower and Deck; one (1) John Deere HPX Diesel Gator; one (1) Brophy Stadium 80 Gallon Sprayer; one (1) John Deere H260 Loader Arms, Bucket and Snow Blade from Deere & Company, 2000 John Deere Run, Cary, NC for an amount not to exceed \$53,683.95.

FISCAL IMPACT

The FY16 General Fund Budget provides funding for the proposed purchases.

BACKGROUND

The proposed equipment purchase will be directly through Deere & Company. All the equipment will be delivered to Plains Equipment Group in Gretna, NE, which will provide warranty work, repairs and parts. The HPX Gator for the Sports Complex will be replacing Gator #2455, a 1993 JD 6x4 Gator. The JD 1570 mower and sprayer will be replacing mower #2220, a 2004 JD 1445 mower. The H260 Loader Arms, Bucket and Snow Blade were scheduled for purchase in FY17, the equipment being part of this Piggyback contract is a savings of approximately \$1,000. The budgeted amount of \$15,000 in FY17 budget will not be used. The purchase stays within budgeted funds for FY16. As part of this purchase package, mower #2218 a 2008 John Deere Z830A mower will be traded in for \$3,900.00.

The purchase is being made off the NE IA Piggyback Grounds Care Equipment contract #4425-5 (PG 0Q).
