SYNOPSIS

A resolution has been prepared to approve a change order to the contract with Swain Construction, Inc. of Omaha, Nebraska to provide for material and labor increases due to the delay of a portion of the contract to 2019 not caused by the Contractor and for signal foundation design work that was required during shop drawing reviews. The contract price increases from \$529,953.11 to \$540,336.11.

FISCAL IMPACT

The FY 19/20 biennial budget includes funding for this project.

RECOMMENDATION

BACKGROUND

The initial contract was awarded to Swain Construction, Inc. on May 15, 2018 in the amount of \$529,953.11. Due to the City Centre Drive intersection relocation being delayed until spring of 2019 from fall of 2018 for reasons not caused by Swain Construction, Inc., there are material and labor cost increases. There was also a requirement for their electrical subcontractor to provide traffic signal foundation designs during shop drawing review which was not part of the original bid requirements. These changes amount to an addition of \$10,383.00. The change order also modifies the completion date for Phases 2 and 3 related to the City Centre Drive relocation to June 9, 2019 for substantial completion and June 24, 2019 for final completion.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING CHANGE ORDER NUMBER 1 TO THE CONTRACT WITH SWAIN CONSTRUCTION, INC., OMAHA, NEBRASKA, TO PROVIDE FOR MATERIAL AND LABOR INCREASES DUE TO THE DELAY FOR A PORTION OF THE CONTRACT TO 2019 AND ADDITIONS OF WORK TO THE CONTRACT FOR AN ADDITIONAL AMOUNT NOT TO EXCEED \$10,383.00.

WHEREAS, the City has determined it is necessary to make changes and additions of work to the contract; and

WHEREAS, the FY19/20 Biennial Budget provides funding for the project. The contract price increases from \$529,953.11 to \$540,336.11

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of La Vista, Nebraska, that the Mayor is authorized to execute the necessary documents for change order number 1 to the contract with Swain Construction Inc., Omaha, Nebraska, to provide for material and labor increases due to the delay for a portion of the contract to 2019 and additions of work to the contract for an additional amount not to exceed \$10,383.00.





7. Stored materials payment will be requested for traffic signal items with no retainage withheld.


