SYNOPSIS

A resolution has been prepared to approve Change Order No. 14 to the contract with Hawkins Construction Co. of Omaha, Nebraska to include some additional pavement. There is no change in the contract price. This change order revises the completion date to coordinate with the adjacent private construction on Lot 15.

FISCAL IMPACT

The FY19/20 biennial budget includes funding for this project.

BACKGROUND

The initial contract for the parking structure project was awarded to Hawkins Construction Co. in the amount of \$3,863,000.00 on November 21, 2017. Previous Change Orders through No. 13 increased the contract price to \$4,146,122.91. Change Order No.14 does not change the contract amount.

This change order revises the current substantial completion date of September 13, 2019 and creates two substantial completion dates. The first date will be September 3, 2019 to complete pavement to the extent required to allow access to the Lot 15 lower level private parking garage. The second date for the completion of the rest of Parking Structure No. 1 will be October 4, 2019.

RESOLUTION NO.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING CHANGE ORDER NUMBER 14 TO THE CONTRACT WITH HAWKINS CONSTRUCTION CO., OMAHA, NEBRASKA, TO REVISE THE SUBSTANTIAL COMPLETION DATE FOR THE PROJECT.

WHEREAS, the City has determined it is necessary to revise the substantial completion date for the project into two substantial completion dates; and

WHEREAS, the first date will be September 3, 2019 for pavement completion to the extent required to allow access to the Lot 15 lower level private parking garage; and

WHEREAS, the second date will be October 4, 2019 for the completion of the rest of Parking Structure No. 1; and

WHEREAS, the FY19/20 Biennial Budget provides funding for the project; and

WHEREAS, change order number 14 will not change the contract amount of \$4,146,122.91;

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of La Vista, Nebraska, that the Mayor is authorized to execute the necessary documents for change order number 14 to the contract with Hawkins Construction Co., Omaha, Nebraska, to revise the substantial completion date for the project.




