SYNOPSIS

A resolution has been prepared authorizing the advertisement for bids for Erosion Control Maintenance in the 84th Street Redevelopment Area.

FISCAL IMPACT

The FY19/20 Biennial Budget includes funding for various Civic Center Park improvements.

BACKGROUND

Providing erosion control maintenance in the 84th Street Redevelopment Area is a requirement of the grading permits that the city has obtained. City-owned property in La Vista City Centre and Civic Center Park, including the site of the Interface Improvements, will be addressed by this contract. At such time as construction contracts are awarded for specific projects, erosion control will be part of those contracts and this contract can be closed.

Preparation of plans and specifications for this project have been completed primarily in-house by the City Engineer. The proposed bidding documents include estimated quantities of work. The actual quantities will depend primarily on weather conditions encountered during the next year. The Engineer's Estimate for the proposed construction work is \$47,600. The recommended schedule for bidding this work is:

Sealed proposals will be received by Pamela Buethe, Clerk of said City, at the City of La Vista, City Hall, 8116 Parkview Boulevard, La Vista, NE 68128, until 10:00 AM on the 20th day of September, 2019, for the furnishing of all labor, materials, use of Contractor's equipment, plant and all else necessary to provide the construction services for EROSION CONTROL MAINTENANCE, 84TH STREET REDEVELOPMENT AREAS.

At such hour, or as soon as practicable thereafter, the City of La Vista will proceed to publicly open in the presence of all bidders and consider the bids received for the furnishing of such labor, materials, and equipment necessary for the proper construction of such improvements.

Each bid shall be accompanied in a SEPARATE SEALED ENVELOPE by a certified check or bid bond in an amount of not less than five percent of the amount bid and such certified check or bid bond shall be payable to the Treasurer of the City of La Vista, Nebraska as security that the bidder to whom the contract may be awarded will enter into a contract to provide the services in accordance with this Notice to Contractors. No bidder may withdraw his proposal for a period of sixty (60) days after the date set for the opening of bids.

The City of La Vista, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office the Secretary, Part 21, Nondiscrimination in Federally assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin, sex, age and disability/handicap in consideration for an award.
