The City of La Vista Planning Commission held a meeting on Thursday, March 20, 2025, in the Harold "Andy" Anderson Council Chambers at La Vista City Hall, 8116 Park View Boulevard. Legal notices of the public meeting and hearing were posted, distributed, and published according to Nebraska law. Notice was simultaneously given to all members of the Planning Commission. **A. Replat Reapproval – Willow Creek Replat Four – Krishna, LLC**

**Staff Report – Cale Brodersen, Associate City Planner:** Brodersen explained that the Planning Commission reviewed this replat along with the Conditional Use Permit for the Bear Creek Apartments this past fall, and that this extension is being brought for their review as the Final Plat expired 90 days after the City Council approval. He mentioned that the applicant was working with their lender to get their final approval, and that process took longer than the 90 day time limit to have the plat recorded which is noted in La Vista's Subdivision Regulations. Brodersen pointed out one small change in the plat that adjusts the property line slightly to keep the property with the existing apartment building at a certain size, which was a requirement of their lender.

**B. Proposed Comprehensive Development Plan Amendment to Adopt and Incorporate the Sarpy County and Cities Wastewater Agency Master Plan into the Comprehensive Development Plan**

**Staff Report – Chris Solberg, Deputy Community Development Director:** Solberg explained the history of the Sarpy County and Cities Wastewater Agency and their work to oversee the construction and operation of the sanitary sewer system to serve the southern portion of Sarpy County. He explained that this agency completed their master plan, and each of the cities and the County, as members of the agency, will be adopting this master plan into their respective comprehensive plans.
