The City of La Vista Planning Commission held a meeting on Thursday, October 16, 2025, in the Harold “Andy” Anderson Council Chambers at La Vista City Hall, 8116 Park View Boulevard. Legal notices of the public meeting and hearing were posted, distributed, and published according to Nebraska law. Notice was simultaneously given to all members of the Planning Commission. ## **A. Zoning Ordinance Amendments – Body Art Services - Sections 2.03 and 5.10**

**Staff Report – Christopher Solberg, Deputy Community Development Director:** Solberg introduced the agenda item regarding a proposed zoning text amendment to permit body art services as an allowed use within the C-1 Shopping Center District. Solberg noted that staff had reviewed comparable zoning regulations in surrounding Sarpy County communities and found that similar uses are permitted within their respective commercial districts.

Commissioner Circo inquired about the applicant's anticipated staffing levels. Applicant Jennifer Simmons responded that she anticipates potentially adding two additional artists in the future but emphasized that any new hires would need to align with the studio's standards to ensure a consistent and high-quality client experience.

Chairperson Alexander opened the Public Hearing.

### **Public Hearing:**

Dick Grube, Jennifer Simmons' previous landlord, came forward and expressed to the Commission that Simmons was a great tenant and he never had any issues with her or her business. He explained that the only reason she will not be able to stay in her current location is because he is selling the building to the school district. Frey moved, seconded by Brewer, to close the public hearing.
