WHEREAS, Metropolitan Utilities District of Omaha ("the District") is a municipal corporation and political subdivision of the State of Nebraska established and governed by Nebraska law to provide natural gas, potable water, and wastewater services to the City of Omaha and surrounding communities; and

WHEREAS, the City of La Vista ("the City"), a city of the First Class, is a municipal corporation of the State of Nebraska that owns and operates a sewer collection system; and

WHEREAS, Neb. Rev. Stat. § 14-2129 authorizes the City to enter into a agreement with the District to obtain the use of the facilities and services of the District to collect all or any part of the sewer use or rental fee for which City may lawfully be entitled to charge and collect; and

WHEREAS, the District bills and collects the City's sewer service fees; and

WHEREAS, the current agreement between the City and the District is dated March 13, 1975; and

WHEREAS, the District has proposed an updated agreement, a copy of which is presented with this agenda item; and

WHEREAS, the City desires to enter into a new agreement whereby the District will collect sewer fees from District customers connected to City's sewer system in exchange for reimbursement of the District's costs by the City; and

WHEREAS, the District is willing to collect and remit the balance of the Sewer Fees to the City after deducting the District's costs under the terms and conditions of this Agreement;

NOW, THEREFORE, BE IT RESOLVED, that that the Proposed Agreement presented at this meeting is approved and the Mayor is authorized to execute such document, subject to such additions, subtractions, or modifications as the Mayor, City Administrator or City Engineer may determine necessary or appropriate.

Re: Economic Development Program Review

The Citizen Advisory Review committee is required to report to the Mayor and City Council at least once every six months regarding the Economic Development Program. Chairman Narak presented to the Council after our June meeting. The following is provided for the Committee's information and generally covers activity for FY25 (the period from October 1, 2024 to September 30, 2025).

The Economic Development Program has received and approved four applications for assistance to date. The first application was from John Q. Hammons to construct a full service Embassy Suites Hotel and conference center facility. This project was closed out in 2018.

The second application was for a \$3 million grant to City Ventures to help with the construction of a state-of-the-art music venue in City Centre, located in the redevelopment area along 84<sup>th</sup> Street. This application was approved in February of 2020. In May of 2021 City Ventures submitted a supplement to their original application asking for an additional \$2.5 million for the music venue project in the form of a loan that will be paid back with interest. This supplement was also approved, resulting in a total of \$5.5 million in grants/loans for the project. The entire \$5.5 million has been distributed to City Ventures. They are currently paying interest on the loan. The music venue is completed and operational.

In October of 2021 an application from the Omaha Multi-Sport Complex, Inc. for a \$3 million grant for the development, construction and operation of Phase 1 of a premier multisport complex comprised of twelve synthetic multisport playing fields and related amenities was approved. This facility is currently operational and the grant funds have been distributed.

1. The City's assessed valuation for FY25 was \$2,404,341,954, and the new assessed valuation for FY26 is \$2,511,621,618. This is an increase of 5.22%. From FY2018 through FY2021, the growth in the City's valuation averaged approximately 4.5% annually. In FY22 and FY23 we saw unusually large increases in valuation which were attributed in part to extreme increases in the personal property tax portion of the valuation. It was determined these increases had to do with large companies in the City that qualify for state incentives purchasing equipment and the timing of their refund requests to the State. The valuation for FY24 saw a leveling off of these personal property tax increases resulting in a smaller overall increase. The average growth over the last eight years is 6.7%.

2. Earned sales and use tax revenue has traditionally increased from year to year, however it was down slightly in FY19 and again in FY20 due to the pandemic. FY21 showed a rebound in sales and use tax revenue and FY22 sales tax numbers remained strong. A reminder that we look at what the City has "earned" in sales tax prior to any state incentive refunds being deducted to calculate growth and in order to determine what businesses are actually generating. The City has built a sales and use tax reserve for potential future rebates. It should be noted that the City has received it's annual letter from

the State of Nebraska indicating what the rebate to SON will be in December of 2025. It is less than \$500,000, which is a large decrease from previous years where rebates have been anywhere from just over a million dollars to nearly two million dollars.

**BACKGROUND**

On November 7, 2023, City Council approved the initial agreement with Design Workshop for preliminary engineering services phase work for the above reference project, with the first amendment to the agreement approved on August 6, 2025.

Other items, such as additional topographic survey, additional right of way exhibits and design for the drainage letdown structure were not adequately scoped, and therefore additional design work was needed to complete said tasks.





Plans required extensive revision due to new construction on the east side of the project.

The deliverable requirements for the transition of the completed local plans to NDOT involved much more effort and plan sheet development than scoped.

#### VII. FINAL PS&E SUBMITTAL/BLUE LINE CORRECTIONS

The scoped level of coordination through the NDOT letting system was based on a simple transition of completed plans to NDOT borders and standard bid items. The final efforts included much more review, checks, and submittals.

#### VII. RIGHT OF WAY DESIGN

47 additional property tracts needed reviewed. Easement tracts, legal descriptions, and CAD work was necessary for all additional tracts.

#### IX. BRIDGE DESIGN

The letdown structure had design covered under the original scope in the Storm Sewer and Drainage section, but no detailing or plan sheet development. Five (5) additional plan sheets were developed as Special Plans.

The geotechnical constraints determined in the undercrossing area required a review of the retaining walls and layout. The final plans resulted in new geometry of the walls, added plan sheets, new specifications, and revised Special Plans.

**SYNOPSIS**

A resolution has been prepared to approve a Right of Way Easement with Omaha Public Power District (OPPD) as a result of the relocation of the overhead power line to the west of the Reflections Plaza project. A subsequent invoice for \$10,710.05 or 50% cost share of the relocation cost is contingent upon the approval of the Right of Way Easement.

**FISCAL IMPACT**

The FY25/FY26 Biennial Budget provides funding for this project.

**RECOMMENDATION**

Approval.

**BACKGROUND**

On April 15, 2025, City Council awarded the bid for Reflections Plaza to Mackie Construction, to which approximately \$57,000 of the items of work were associated with the underground relocation of the existing OPPD overhead power line which ran in conflict with the project.

In partnership with OPPD, value engineering efforts were undertaken in which the alternate of relocating the overhead power line to the west of the project was proposed, to which in exchange for memorializing the relocation within an easement, OPPD would share 50% of the cost of relocating the overhead line. The 50% cost share of the relocation to the City is \$10,710.05, which resulted in approximately \$46,000 of cost savings to the project.

Staff recommends the attached Right of Way Easement and invoice be approved. Once the easement is approved, action is required to approve the \$10,710.05 invoice from OPPD.

A copy of both the Right of Way Easement and invoice are attached.

The District shall have the nonexclusive perpetual right, but not the obligation, to trim, cut, clear or remove all trees, brush, undergrowth and other obstructions from the surface and to trim, cut, or remove any other trees located outside the Easement Area which in falling could come within fifteen (15) feet of the electric lines as may be necessary to efficiently exercise any of the hereinbefore granted rights. All refuse from such tree and brush cutting or trimming shall be disposed of by the District, and if the Easement Area is not being utilized for cultivated crops, the District

shall have the further right but not the obligation to control and impede the growth of all weeds, trees, and brush along (within) the Easement Area and to temporarily open any fences crossing said area.

Not in limitation of the foregoing, Grantor may cultivate, enjoy, and otherwise use the land within the Easement Area, including the right of ingress and egress to, from and across the Easement Area, provided that such use(s) shall not, in the reasonable opinion of the District and Grantor, endanger or be a hazard to or interfere with the hereinbefore granted rights. Grantor shall not allow buildings, structures, improvements, trees, hay or straw stacks, retaining walls or loose rock walls, or other property to remain or be placed in said Easement Area, but the same may be used for gardens shrubs, landscaping, paving and other purposes that do not then or later interfere with the aforesaid uses or rights herein granted. Grantor and District each agrees shall not change or alter the grade of the Easement Area without the prior written approval from the other party, which approval shall not be unreasonably withheld; Grantor shall not allow the burning of any materials of any nature within the Easement Area.

The District shall have the right of ingress and egress across the Grantor Property for any purpose hereinbefore granted. Such ingress and egress shall be exercised in a reasonable manner and only when reasonably necessary.

In the event of any improvements, work, use, ingress or egress, upon, within, to or from the Easement Area or exercise of any other rights hereunder by District, District at its cost and expense shall restore all land surfaces, pavement, improvements and property affected by such improvements, work, use, ingress, egress or exercise to a condition that is the same as or better than existing prior to such improvements, work, use, ingress, egress or exercise, including without limitation repaving any paved areas, reseeding any established lawns, and restoring any landscaping or other improvements.

Not in limitation of the foregoing, The District shall pay Grantor and/or lessee of Grantor, as their interests may appear, for all damages to growing crops, fences or other property on the Grantor Property which may be caused by the exercise of the hereinbefore granted rights. It is further agreed that all claims for such damages must be submitted in writing.

It is further agreed that the Grantor has lawful possession of said Grantor Property, good, right and lawful authority to make such conveyance and that his/her its/their heirs, executors, administrators, successors and assigns shall warrant and defend the same against the claims of all persons whatsoever in any way asserting any right, title or interest contrary to this conveyance that are caused by any title defect that arise during Grantor's ownership of such Grantor Property.

The undersigned agrees and represents that he/she has read and understands the Right-of-Way Easement and that this easement shall run with the land, constitutes the entire agreement between the parties, and the undersigned has not relied upon any promises, inducements, covenants, oral statements, or agreements of any kind or natures which are not expressly set forth herein. This Right-of-Way Easement shall be binding upon the respective grantees, licensees, lessees, successors, heirs and assigns of the parties.
