LA VISTA CITY COUNCIL MEETING December 18, 2012

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on December 18, 2012. Present were Councilmembers: Gowan, Ronan, Sheehan, Carlisle, Crawford, Quick, Hale, and Sell. Also in attendance were City Attorney McKeon, City Administrator Gunn, Assistant City Administrator Ramirez, City Clerk Buethe, Finance Director Lindberg, Police Chief Lausten, Fire Chief Uhl, Public Works Director Soucie, City Planner Solberg, Public Building and Grounds Director Archibald, Recreation Program Coordinator South, Library Director Barcal, and City Engineer Kottmann.

A notice of the meeting was given in advance thereof by publication in the Times on December 5, 2012. Notice was simultaneously given to the Mayor and all members of the City Council and a copy of the acknowledgment of the receipt of notice attached to the minutes. Availability of the agenda was communicated to the Mayor and City Council in the advance notice of the meeting. All proceedings shown were taken while the convened meeting was open to the attendance of the public. Further, all subjects included in said proceedings were contained in the agenda for said meeting which is kept continuously current and available for public inspection at City Hall during normal business hours.

Mayor Kindig called the meeting to order and led the audience in the pledge of allegiance.

SYNOPSIS

A resolution has been prepared to approve the purchase one (1) 2013 Ford Police Interceptor Utility vehicle from Anderson Ford, Lincoln, Nebraska and up-fitting from 911 Custom, Overland Park Kansas, in an amount not to exceed \$39,500.

FISCAL IMPACT

The FY 13 General Fund budget provides funding for the proposed purchase.

RECOMMENDATION

BACKGROUND

The purchase is being made off of the Nebraska State Contract. Funding was provided in the FY 13 General Fund budget for the purchase of one (1) marked police vehicle. Expected delivery of the vehicle will be 90-120 days (May 2013).

Sgt. Waugh was assigned to meet with head mechanic Ray Crane to discuss cruiser selection options for 2013. In an effort to diversify the fleet, a decision was made to recommend the purchase of one (1) marked Ford Police Interceptor Utility vehicle. At this time the existing Dodge Charger Police Fleet serves the department well in the area of rear wheel drive sedans, however; with the option of the Ford Utility we have the opportunity to add an AWD Police Pursuit Rated vehicle to the fleet without exceeding the cost of the Dodge Charger. The Ford Utility comes equipped with the 3.7L V6 engine which will offer slightly better fuel mileage for City driving without sacrificing horsepower.

Sgt. Waugh met with police sergeants from surrounding agencies who are currently driving the Ford Police Interceptor Utility. Each provided favorable comments about its performance in the field. The vehicle offers a large drivers area in the cab and large storage space in the rear hatch. The vehicle will be up-fitted via 911 Customs in Overland Park, KS. We have successfully worked with this company before as they have performed warranty repairs on our police emergency lighting and other components. 911 Customs came to La Vista in December and provided an example of the vehicle and installed equipment.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska, do hereby accept the Nebraska state bid of Anderson Ford, Lincoln, Nebraska and authorize the purchase of one (1) 2013 Ford Police Interceptor Utility Police vehicle and up-fitting from 911 Customs, Overland Park, Kansas, in an amount not to exceed \$39,500.
