SYNOPSIS

A resolution has been prepared authorizing the advertisement of bids for installation of the 124th Circle and Harrison Street Traffic Signal Improvements.

FISCAL IMPACT

The FY 14 Capital Budget provides funding for the 124th Circle & Harrison Street Traffic Signal (aka Eastport Parkway & Harrison St Traffic Signal), Project No. PWST-17-001. Performance Auto Group has agreed to contribute \$75,000 to the project which was based on 50% of the preliminary project cost estimate. The Engineer's Estimate currently exceeds the budgeted funds. At such time as bids are received, then a decision about costs and funding will need to be made. After bids are taken and firm costs are identified, then a request for Performance Auto Group for their contribution will be made prior to awarding the contract.
