





LA VISTA CITY COUNCIL MEETING November 17, 2015

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on November 17, 2015. WHEREAS, the City Council of the City of La Vista has determined that the purchase of new unmarked police vehicles is necessary, and

WHEREAS, the FY16 General Fund budget and Narcotic Forfeiture account balance include funds for the purchase of two (2) said vehicles, and

WHEREAS, the State of Nebraska did receive bids for 2016 vehicles, and

WHEREAS, Husker Auto Group, Lincoln, Nebraska, was awarded the state bid for Nebraska for the 2016 Chevrolet vehicles, and

WHEREAS, Subsection (c) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secure Council approval prior to authorizing any purchase over \$5,000.00.

Councilmember Quick introduced and moved for the adoption of Resolution No.15-139; A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING THE PURCHASE OF A COMPRESSED NATURAL GAS (CNG) CONVERSION FROM FUEL CONVERSION SOLUTIONS, OAK GROVE, MISSOURI FOR AN AMOUNT NOT TO EXCEED \$9,650.00.

Present was Recreation Director Scott Stopak, Asst. Director David Karlson, Program Coordinators Ryan South and Rich Carstensen, Golf Course Services Manager Denny Dinan, and from Public Works Rob George. Advisory Board Members present were Chairperson Pat Lodes, Joe Juarez, Jeff Kupfer and Greg Johnson.

All proceedings hereafter were taken while the convened meeting was open to attendance of the public. CALL TO ORDER

Recreation Director Scott Stopak called the meeting to order.

Stopak led the audience in the Pledge of Allegiance.

Stopak made an announcement of the location of the posted copy of the Open Meetings Act for public reference and read the Emergency Procedures Statement.

2. REPORTS FROM RECREATION DIRECTOR AND STAFF

Asst. Recreation Director Karlson reported on Special Events and Programs:

Preschool Playtime Craft Day was held on Tuesday September 10th. 16 preschool and 11 adults made colorful fall trees using create paper and bingo daubers. Discover Play Home School class started again on Thursday September 17th. 42 kids grades Kindergarten through 4th grade joined us in discovering a variety of games that taught collaboration, cooperation and teamwork. At the same time, we had open play activities for their younger siblings. We had 18 preschoolers and 26 parents attend. Program Coordinator South reported on current sport activities for adult and youth.

Flag Football for grades Kindergarten-6th ended their season on October 10th.

4/5 Soccer Academy & 6/7 Soccer League held their last session on October 10th.

Adult Softball leagues are in their final week. Due to rain outs, the season was extended slightly for some leagues.

Tackle Football & Cheerleading are in week 6 of a 9 week season. Tackle football will end their season on November 1st.

Youth Volleyball for grades 3rd-6th began practicing on September 28th. We have two 3/4 grade and two 5/6 grade teams this season. This season we have joined forces with the South Sarpy Volleyball Club to create the South Sarpy La Vista Volleyball League, a cooperative league between South Sarpy and La Vista Rec. We are very excited about this joint league with South Sarpy. The first games of the season will begin on October 17th. All 3/4 grade teams will play at the La Vista Community Center and our 5/6 grade teams will play games at both the Community Center and Platteview High School.

She will talk about her books and the lighter side of her life. Friday, October 16th we will have a Black Jack Tournament. Monday, October 19th we will have White Elephant Bingo. Wednesday, October 21st we will take our monthly trip to the Movies. On a regular basis we have 10-14 seniors go to the movies. Thursday, October 22nd the senior center sewing/quilting group took a trip to Hamilton, MO to the Missouri Star Quilting Company and the other local sewing shops, which are also owned by Missouri Star Quilting. It is the hometown of James Cash Penney, founder of J.C. Penney's department stores. While the women hunted for sewing bargains, I studied at the town's history museum.

Sunday, October 11th the La Vista Recreation Department along with the Midwest Winds Kite Flyers held the annual One Sky, One World Fall Kite Fly from 12-4 p.m. The temperature was hot but the wind was almost perfect for a great day of kite flying. Kids enjoyed not only flying kites but also took turns playing

under the giant caterpillar and enjoyed the candy they grabbed from the kite candy drop. Everyone young and old had a great time and we look forward to having La Vista's Spring Kite Fly on Sunday, April 3rd.

Golf Course Services Manager Dinan reported on the La Vista Falls Golf Course for September, 2015:

Golf Rounds September 2015 = 1,699 (- 295 rounds from September 2014)

FootGolf Rounds September 2015 = 260

Total Rounds September 2015 = 1,959 (-35 rounds from September 2014)

Golf Rounds Fiscal Year 14/15 thru Sept. = 16,937 (-271 Golf rounds from fiscal year 13/14)

FootGolf Rounds Fiscal Year 14/15 thru Sept. = 1,614 (+1,614 FootGolf rounds from fiscal year 13/14)

Total Rounds Fiscal Year 14/15 thru Sept. = 18,551 (+ 1343 total rounds from fiscal year 13/14)

September started off hot and humid with the first 6 days being above 90 degrees. During the remaining 24 days there were 9 days of rain, sometimes very heavy, and the course was wet. With meetings only twice a month this has created some instances where an applicant could not have an SDL for an event simply because the City Council meeting date would make the application late to the State who requires it be there 10 business days prior to the date of the event – no exceptions.

A Council Policy Statement is proposed to establish a uniform procedure for the recommendation to the Nebraska Liquor Commission to approve/deny an application for a Special Designated Liquor License (SDL) within the City of La Vista without having to go through City Council. Staff would follow their current process of review by the Chief of Police and would add review by the Chief Building Official.

This new policy would be sent to all current liquor license holders in the City of La Vista.

Special Designated Liquor License Procedure

The purpose of this policy statement is to establish a uniform procedure for the recommendation to the Nebraska Liquor Commission (NLC) to approve/deny an application for a Special Designated Liquor License (SDL) within the City of La Vista.

The City Council has determined that it is in the best interests of the City and the Community to have the approval process run through the office of the City Clerk and that these do not need to go before the City Council for approval.

The following guidelines will be applied by the City Clerk in reviewing applications for special designated liquor licenses for the consumption of alcoholic liquors.

An application for a special designated liquor license will be recommended for approval by the City Clerk only when:

1. A favorable police report has been issued relating to the type and level of security to be provided to insure that the liquor laws, and in particular the liquor laws relating to the sale to and consumption by minors, will be complied with.
2. Adequate restroom facilities are available or will be provided.
3. The granting of such a permit will not create traffic congestion or hazards, and will not violate any of the provisions of the La Vista Municipal Code.
4. The application otherwise complies with the requirements of the Nebraska Liquor Control Act, including without limitation Neb. Rev. Stat. §53-134 and all rules and regulations as outlined by the Nebraska Liquor Control Commission.
5. The application for special designated liquor license is submitted for review at least twenty one (21) working days prior to the event date.
6. The application is approved by the chief building official or their designee.

An application for a special designated liquor license will be recommended for denial by the City Clerk when:

1. An unfavorable police report has been issued relating to the type and level of security to be provided to insure that the liquor laws, and in particular the liquor laws relating to the sale to and consumption by minors, will be complied with.
2. Adequate restroom facilities are not available or will not be provided.
3. The granting of such a permit will create traffic congestion or hazards, and/or will violate any of the provisions of the La Vista Municipal Code.

4. The application does not comply with ~~the any~~ requirements of ~~the Nebraska Liquor Control Act Neb. Rev. Stat. §53-134 and all or any~~ rules ~~and or~~ regulations as outlined by the Nebraska Liquor Control Commission.
5. The application for special designated liquor license is submitted for review at less than twenty one (21) working days prior to the event date.
6. The application is not approved by the chief building official or their designee.
7. The application requests authorization to sell or consume alcoholic liquors beyond the hours for sale at retail and dispensing authorized in Chapter 114 of the La Vista Municipal Code.

The City Clerk shall then issue a response to the NLC either recommending approval or denial of the SDL.

These guidelines shall be applied to all applications for special designated liquor licenses for the consumption of alcoholic liquors. Nothing herein shall preclude the City Clerk in conjunction with the Chief of Police and Chief Building Official from deviating from the above-stated guidelines when exceptional or peculiar circumstances exist warranting such a deviation.

BACKGROUND

On March 5, 2002, the City Council passed Resolution No. 02-022 authorizing the Mayor to execute an Interlocal Cooperation Agreement with Sarpy County, the cities of Gretna, Papillion, Springfield and Bellevue, and the Papio Missouri River Natural Resources District for the development and implementation of a Geographic Information System (GIS). On October 2, 2007, the City Council passed Resolution No. 07-106 updating the GIS Interlocal Agreement and creating a coalition GIS user group.

The GIS coalition continues to consist of the City of Gretna, City of Papillion, City of Bellevue, City of Springfield, City of La Vista, County of Sarpy, Papio Missouri River Natural Resource District.

The addendum only changes to cost for the 2016 aerial photography acquisition.

ADDENDUM TO GEOGRAPHIC INFORMATION SYSTEM (“GIS”) INTERLOCAL AGREEMENT

This Addendum is entered into by and between City of Gretna, Nebraska (“Gretna”), City of Papillion, Nebraska (“Papillion”), City of Bellevue, Nebraska (“Bellevue”), City of La Vista, Nebraska (“La Vista”), City of Springfield, Nebraska (“Springfield”), (hereinafter collectively called “Cities” or a “City” when used in the singular), County of Sarpy, Nebraska, a body politic and corporate (“Sarpy”), and the Papio Missouri River Natural Resource District (“PMRNRD”), (collectively the “Parties”; each individually a “Party”).

WHEREAS, the parties have previously entered into an Interlocal Agreement to develop and implement a Geographic Information System (“GIS”); and,

WHEREAS, the Parties are desirous of amending the provisions of said Agreement by this Addendum.

NOW, THEREFORE, it is hereby agreed by and between the parties:

The prior Agreement between the parties is hereby amended by the terms of this Addendum.

II.

Exhibit A of the previous Agreement, as amended, shall be amended to include updates for the “Aerial Photo Share,” a copy of which is attached to this Addendum.

III.

Exhibit B of the previous Agreement, as amended shall be amended to include updates for the costs associated with the 2016 aerial photography acquisition.

IV.

Each Party shall make payment and otherwise perform under the terms of the previous Agreement and the subsequent amendments thereto, applying the amendments of Exhibit A and B attached hereto.

IV.

The remaining terms and conditions of said prior Agreement shall remain unchanged.
