**SYNOPSIS**

A resolution has been prepared authorizing the payment for an emergency electrical repair at the Public Works Facility by Vierregger Electric Co, Omaha, Nebraska, for an amount not to exceed \$6,540.00.

The FY 16 Street, Parks and Sewer Operational Budgets have funding available to cover the expenditure.

**BACKGROUND**

On July 26, 2016, Morris Excavating was removing the fuel tanks at the Public Works Facility. The electrical supply line running from the main building to the sewer division shop on the east end of the property was inadvertently not marked and subsequently damaged during excavation. Marking of the electrical line was the responsibility of Public Works. A temporary repair was completed on June 26<sup>th</sup>. In order to replace the removed concrete, permanent repairs need to be completed to close out the project.

**RE: Replace conductors between Main Building and Sewer Shop**

Dear Ray:

Thank you for your recent call on 7-26-16. On that day, our crew made temporary splices to damaged conductors to restore power to the Sewer Shop. These splices probably will not survive long term, and the conductors should be replaced for best results in the future. Based upon Dave Vierregger's visit with you today, we are pleased to present the following Proposal for your consideration.

**SCOPE:** Make minor repairs to conduit as necessary; furnish and install four lengths of #1 AWG THHN copper power conductors, and one length of #6 THHN copper grounding conductor, all approximately 600 Linear Feet.

Materials	\$ 3,660.00
Labor & Equipment (32 hrs @ \$90.00)	<u>2,880.00</u>
Total Quoted Price	\$ 6,540.00

This price is based on a Spot Copper price of \$2.20 per pound on the date shown above. If the commodity price of copper changes significantly between the date of this proposal and the date of your acceptance, we reserve the right to refresh this proposal as necessary to reflect the appropriate commodity price. We would be available to begin this work immediately with your notice to proceed.
