**SYNOPSIS**

A resolution has been prepared to award a contract to Yano's Nursery, Inc. of Omaha, Nebraska for furnishing and installing shrubs and trees for the Thompson Creek Landscaping (Phase One) in an amount not to exceed \$27,220.00.

**FISCAL IMPACT**

The FY17 Capital Improvement Program provides funding for this project.

**BACKGROUND**

On August 16, 2016, the City Council approved a resolution which authorized the advertisement for bids for this project. The plans and specifications were prepared by RDG Planning & Design. Bids were received on September 9, 2016 at 10:00 am. Three bids were received and are summarized as follows:

Yano's Nursery, Inc.	\$27,220.00
Jensen Gardens	\$28,751.50
Mulhall's Nursery	\$42,000.00

The bid from Jensen Gardens contained a number of exceptions to the specifications. The bid from Mulhall's Nursery did not acknowledge Addendum No. 1.

Yano's Nursery, Inc. is a qualified contractor and it is recommended that a contract be awarded to them in an amount not to exceed \$27,220.00.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AWARDING A CONTRACT YANO'S NURSERY, INC., OMAHA NEBRASKA FOR FURNISHING AND INSTALLING SHRUBS AND TREES FOR THE THOMPSON CREEK LANDSCAPING (PHASE ONE) IN AN AMOUNT NOT TO EXCEED \$27,220.00.

WHEREAS, the City Council of the City of La Vista has determined that installation of shrubs and trees for the Thompson Creek Landscaping (Phase I) project is necessary; and

WHEREAS, the FY17 Capital Improvement Program provides funding for this project; and

WHEREAS, Bids were solicited and three bids was received, and

WHEREAS, Yano's Nursery, Inc. Omaha Nebraska has submitted the most qualified bid, and

WHEREAS Subsection (C) (9) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secures Council approval prior to authorizing any purchase over \$5,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska award a contract to Yano's Nursery, Inc. Omaha Nebraska for furnishing and installing shrubs and trees for the Thompson Creek Landscaping (Phase I), in an amount not to exceed \$27,220.00.
