**SYNOPSIS**

A resolution has been prepared authorizing the purchase of M1000 Caliber Liquid Deicer for use by the Public Works Department from Enviro Tech Services Inc., Greeley, Colorado, for an amount not to exceed \$10,000.00.

**BACKGROUND**

The liquid deicer is used by the Public Works Department for winter operations. Orders are placed at different times throughout the winter season as needed. Normal delivered loads are approximately 4,000 gallons at a price of \$2,600.00.

Enviro Tech Services is the sole provider of this product in Nebraska.
