SYNOPSIS

A resolution has been prepared authorizing the purchase of 125 tons of Ball Field Aggregate from Bryan Rock, Inc., Shakopee, MN, for an amount not to exceed \$7,500.

BACKGROUND

Ball Field Aggregate is currently used on all of our baseball/softball infields. This purchase will be used to repair the infields. The infields naturally lose material each year due to wind blow-off and water erosion. This is an on-going maintenance activity.
