Looking Back - Looking Ahead

It is that time of year again when we take a moment to look back at how we have grown and changed as a City over the last twelve months, and also contemplate the challenges that lie ahead as we continue our efforts to provide high quality public services to all of the citizens of La Vista.

As 2006 began, the City was dealing with significant change. Douglas Kindig had just been sworn into office as Mayor, Kelly Sell was appointed to fill a vacant Council seat in Ward IV and the City was searching for a new City Administrator. Brenda Gunn (the former Assistant City Administrator) was appointed to that position in April, Rita Ramirez (the former City Clerk) accepted the Assistant City Administrator position in September, and Pam Buehe (former City Clerk in Gretna, NE) was recently appointed to the position of City Clerk in La Vista. As the year ended, four incumbent Council members were re-elected to their positions. We are poised to move forward with a visionary body of elected officials in place and a good combination of experienced management personnel.

Construction on the City's second fire station began early in 2006 and the 22,450 sq. foot facility will be ready for occupancy by late February or early March. The building provides five drive-through bays for fire and other emergency apparatus, as well as locker room, administrative and storage

space. Over the past two years the City has purchased two new ambulances and currently has a second aerial and pumper truck on order. The volunteer firefighters in La Vista do an outstanding job and this facility will be a welcome addition as we continue our efforts to provide efficient and effective emergency services to our growing population.

The Police Department said goodbye this year to its first K-9. Police dog Cosmo was officially retired on July 5. During his nearly eight years of service Cosmo and his handler participated in over 1,400 K-9 uses and public demonstrations, assisting in 462 arrests, 406 of which were drug related. The Department replaced Cosmo with a newly trained K-9 named Leda.

A traffic unit was instituted by the Police Department this year and will continue to be visible throughout the City. (See page 3 for complete details).

A new website was unveiled this summer, made possible through a contest sponsored by the CivicPlus organization. La Vista's website was completely redesigned and is being hosted free for one year, an approximate \$20,000 value. We are currently averaging over 300 visitors to the site per day. An abundance of information is available in a user-friendly format, making City services more easily accessible to citizens. We encourage you to visit us at www.ci.la-vista.ne.us

Work continued throughout the year on the City's municipal aquatics study. In February Water's Edge Aquatic Design presented a report to the Mayor and City Council evaluating the existing pool and providing recommendations for improvement. Several immediate safety concerns were addressed prior the opening of the pool

for the 2006 season. The Mayor also appointed a Swimming Pool Advisory Committee to provide input from the public regarding this process. The Committee has met several times and their goal is to develop a conceptual plan for a potential aquatics facility to be presented to the City Council.

The highly anticipated opening of Cabela's in La Vista's Southport West Subdivision took place in November. It is an amazing retail facility and will be instrumental in helping to make this area a destination location. The City also unveiled the Southport parking facility late this fall. Preliminary work has started on the John Q. Hammons Embassy Suites Hotel and Conference Center, expected to open in June of 2008. A second JQH hotel is also planned in Southport West. Several new office buildings have located in Southport East, and construction is underway on a

A MINUTE WITH mayor kindig



As I reflect back on my first year as your Mayor, it has been both an exciting and challenging time. Upon taking office I was faced with the challenge of finding a replacement for our City Administrator who had accepted a new position.

After an extensive search, we determined that our best candidate was Brenda Gunn, our then Assistant City Administrator. Gunn's professional approach to city management and her experience with the City of La Vista made her the ideal candidate to keep the City on track and help a new Mayor learn the ropes. I am proud to say that the transition has gone extremely well and the City has continued to grow and prosper.

The year ended on a very upbeat note with the opening of Cabela's and the City's parking facility in November. These projects and the creation of Southport as a "gateway" to La Vista are something that the City Council and I have been working on for several years. Southport East is turning into a premier office park area. PayPal, the Southport Professional Building, Hampton Inn & Suites, Pinnacle Bank, Fantasy's, and several other businesses have chosen to locate in Southport East. In Southport West, preliminary construction work has started on the John Q. Hammons Embassy Suites Hotel and Conference Center (expected to open in June of 2008). The developer continues to market the remaining area as an upscale destination location, hoping to attract diverse retail and entertainment venues.

While we are excited about the development taking place on the western edge of the City, there have been challenges in other areas. The loss of WalMart and the potential loss of other businesses along the 84th Street corridor is a concern. The City continues to work with WalMart and other developers regarding this area. Ultimately, the financial benefit resulting from our new development will help with efforts to revitalize existing areas such as 84th Street.

In November, the citizens of La Vista re-elected four incumbent Council members to new terms. The La Vista City Council is a dedicated body that has always maintained a high level of integrity and professionalism. I am proud to serve with them and to be the Mayor of this City at such an exciting time in its history. We are looking forward to a great 2007!

A Child is Missing Program

The La Vista Police Department has a new resource to aid investigators when a child is missing. When police receive a report of a missing child or an elderly person with Alzheimer's disease or disabilities, they can contact the "A Child Is Missing" Center based in Fort Lauderdale, Florida.

The center establishes a radius around where the individual was last seen and blankets the homes and businesses with a recorded notification. The messages ask people to contact local law enforcement with any information about the missing person. The center can place 1,000 calls each minute.

Unlike an Amber Alert, which can be issued only if it is suspected that a child has been abducted, the "A Child Is Missing" system can be utilized in a broader range of circumstances.

The system was put into action in La Vista on November 28th after a mother reported her 11-year-old daughter missing. Neighbors received a recorded message with the girl's description and were asked to call the La Vista Police Department if they knew her whereabouts.

The girl was located approximately 10 minutes after the alert went out, but her mother said she feels better knowing that police have the capability to get the word out quickly when children are missing.

La Vista Police Chief Bob Lausten reported that the police department was introduced to the program last summer at a training conference.

La Vista Police Accepting Applications for Citizens Public Safety Academy

In March, the La Vista Police will again present the Citizens Public Safety Academy, an 11-week training session that will cover a wide variety of police work and fire services. Classes will be held every Wednesday night from 6:30 to 9:30 P.M. and will be taught by officers from the La Vista Police and Fire departments. La Vista Police Roll Out the Traffic Unit

The La Vista Police Department has created a new unit to address the number one concern cited by City residents - traffic. The unit began their mission on November 13, 2006.

The Traffic Unit is a branch of the Police Department's Special Enforcement Bureau and is responsible for traffic safety throughout the city. It is comprised of four police officers supervised by the Operations Commander, Lt. DJ Barcal. Officers Andrew Johnson and Ray Harrod, day shift traffic officers, are also trained as motor officers riding Harley-Davidson "Electra Glide" Police Motorcycles. The motorcycles were obtained through traffic safety grants from the Nebraska Office of Highway Safety. Officers Greg Carrico and John York are assigned to the night shift. Officer York is also the department's K-9 handler and patrols with his K-9 partner, Leda.

It is the mission of all La Vista Police Officers, and of the La Vista Police Traffic Unit in particular, to make the City of La Vista a safe place to drive. We see first hand the devastation and tragedy which can result from negligent, criminal, or thoughtless acts committed behind the wheel. Upon assignment to the Traffic Unit, officers agree to commit themselves to pro-actively addressing the various causes of traffic related deaths and injuries. It is an unfortunate reality that the most effective way to modify bad driving habits is through a strong enforcement profile.

In addition to enforcement efforts, the Traffic Unit investigates all fatal collisions occurring in the city, serious collisions involving great bodily injury, and conducts hit and run follow-up investigations.

Community Development Department

Beautiful Savior Lutheran Church

Construction is underway on a 49,000 s.f. religious facility that will include sanctuary space (seating for 750), classrooms, a social hall, meeting rooms, administrative offices, an outdoor basketball court for church members, and a licensed daycare facility. Location: 96th & Melissa Street.

Cabela's

Construction is complete and the 130,000 s.f. destination superstore in the Southport West development opened in November of 2006. Inside, the outdoors comes alive with hundreds of museum-quality animal displays, giant freshwater aquariums stocked with native fish and a huge selection of hunting, fishing, camping and outdoor gear. Location: 12703 Westport Parkway.

District 2 Fire Station

Construction is nearing completion on the City's 22,450 s.f. facility. The station is scheduled to be open and operational by March of 2007. Location: 7703 S. 108th Street.

Embassy Suites

Construction has begun on a 248,000 s.f., seven story, hotel with 257 rooms. The hotel will have a full height atrium with dining and lounge seating, two fountains, and full height trees. Amenities at the hotel will include an indoor pool with a hot tub, health and exercise facility, and outdoor sun deck. The hotel atrium will be connected to a conference center by a wide concourse which is to include a restaurant and coffee shop. The proposed conference center will have a capacity of 5,000-6,000 people with a full kitchen, and will be marketed for conventions, corporate meetings, trade shows, fund raising dinners, wedding receptions, etc. Location: 12520 Westport Parkway.

Hampton Inn & Suites

Construction is underway on a 4-story hotel with 116 rooms. The hotel will provide a complimentary breakfast, and an enhanced indoor pool and whirlpool. Construction is expected to be completed in June 2007. Location: 12331 Southport Parkway.

Judson Baptist Church

Construction is underway on a church expansion project which will include a new 16,000 s.f. building to be used as a fellowship hall. Location: 8517 Park View Blvd.

Oriental Trading Company

Construction is nearing completion on a 137,000 s.f. warehouse and office addition to their new facility. Location: 11201 Giles Road.

Papio Valley Condominium Warehouse

Construction has started on a 34,000 s.f. industrial flex building. Location: 12115 Centennial Road.

PayPal

Construction is nearing completion on a new 2-story, 130,000 s.f. building. This is PayPal's second facility in La Vista. Location: 7700 Eastport Parkway.

Peel's Salon Services

This \$4.4 million building is the new corporate office for Peel's, a wholesale distributor of salon supplies. The 96,000 s.f. building opened in October 2006. Location: 11720 Peel Circle.

Pinnacle Bank

Construction is underway on a new 3,251 s.f. bank. Location: 12350 Southport Parkway.

Portal Road Flex Buildings

Construction is underway on two new industrial flex buildings, each with 15,000 s.f. Location: 11529 Portal Road.

Productivity Inc.

A 38,000 s.f. warehouse and office facility is under construction for this machine tool distribution company. Location: 8402 S. 117th Street.

Southport Professional Building

A building permit has been issued for a second office building on an adjoining lot. Location: 12110 Port Grace Blvd.

Parking Facility Receives Award

The Nebraska Concrete Paving Association annually accepts nominations and rates Portland cement concrete pavement projects in several categories to determine the best designed and constructed projects. Based upon these ratings, awards are presented in several categories. This program is intended to encourage high quality workmanship in concrete pavement projects.

On January 17, 2007 the Association presented awards for 2006 projects. The City of La Vista's public parking facility received the award in the Parking Lots and Other Miscellaneous Paving category. City Engineer John Kottmann was recognized for his design work on the project and Andrus Enterprises was recognized for construction of the facility. The high profile water feature included in this project was both a design and construction challenge; however, it contributes to the uniqueness of the parking facility and sets the tone for the entire Southport development. The City of La Vista is extremely pleased with the results.

Temporary Signs

A temporary sign, as defined in the City's zoning regulations, is a sign constructed of cloth, fabric, or other material with or without a structural frame intended for a limited period of display, including displays for holidays or public demonstrations. Portable signs are included. Temporary signs cannot exceed thirty-two (32) square feet (8' X 4' for example) and cannot be of such size, message, or character so to harm the public, health, safety or general welfare. Temporary signs cannot be in place for more than fourteen (14) consecutive days, except that real estate signs may be placed until the property sale is finalized and construction signs may be in place until that construction phase is completed

but must be located on the property under construction. With the exception of real estate and construction signs, temporary signs require a permit. No more than (4) temporary sign permits can be issued for one property in a calendar year.

A general rule for the placement of a temporary sign is it cannot be in the right-of-way and so must be 25 feet back from the street curb on major streets (72nd Street, Giles Road and Harrison Street), 50 feet back from the curb on 84th Street, and 12 feet back from the curb on residential streets. This would mean at an intersection, attention would have to be paid to both streets involved in the placement of a temporary sign. In addition, signs may not

Annual Clean-up Days

The City's Annual Clean-up Days will be held on Friday, April 13 and Saturday, April 14, 2007. All residents; including residents in the City's Extra-Territorial Zoning Jurisdiction, are encouraged to take advantage of this FREE disposal service by bringing discarded items to the Public Works Facility, 9900 Portal Road. Hours of operation will be 7:30 a.m. to 3:30 p.m. Examples of items that will be accepted include: major appliances, lawn and household furniture, toys, bikes, tires, lawn mowers, grills and mattresses. There will be a separate dumpster to collect yard waste, leaves and grass clippings. Yard waste must be removed from non-biodegradable bags. Branches will be accepted if their diameter is less than 6 inches. Motor oil and anti-freeze will be accepted but must be free of debris. Household batteries and car batteries will also be accepted. Paint and hazardous waste will not be accepted. Proof of residency will be required, either a valid drivers license or a utility bill.

Planning on Installing a Swimming Pool?

Remember to obtain all necessary permits first! La Vista City Code Section 150.47 and 150.51 requires that permits be acquired before work has commenced. A building permit is needed for the pool, an electrical permit if a pump is being used, and a fence permit for the enclosure around the pool.

The definition of a swimming pool is any above ground or below ground body of water in an artificial or semi-artificial receptacle or other container, over two feet in depth used or intended to be used for swimming or bathing.

Change in Tax Levy



After the City's 2006/2007 budget was adopted and submitted to the State of Nebraska and Sarpy County, an inadvertent error was discovered by City staff. The tax levy approved and published as part of the budget process was \$.4935. The amount of property tax requested in the budget document calculated back to a tax levy of \$.498435.

An additional \$32,160.95 was included in the total amount of property tax requested this year to cover the 1% fee charged by the county for the collection of property taxes. The inclusion of this fee in the property tax request was recommended by the State Auditor's Office. The mistake made was that the levy was not recalculated after the addition of the \$32,160.95. The State and County did not discover the error as they look only at the total amount of property tax requested and calculate and set the official levy accordingly. As a result, the City's tax levy was set at \$.498435, not at \$.4935 as intended.

When staff became aware of the error, an attempt was made at both the State and County level to remedy the situation and adjust the amount of property tax requested to produce the intended levy. Unfortunately, the deadline for any revisions to the budget had already expired.

As a result, the City's new tax levy will mean an increase of \$4.94 per year for the owner of a home valued at \$100,000; \$7.40 per year for a home valued at \$150,000 and \$9.87 for a home valued at \$200,000.

The City regrets this error and has taken appropriate steps to ensure that this type of mistake will not occur in the future. If you have any questions please feel free to contact City Hall at 331-4343.
